

General overview of Continuing Education with ILPPP programs, Summer 2017 through Spring 2018

Certificate of attendance

A general certificate of attendance will be provided at no charge. This may satisfy many participants' needs. There is no charge.



Award of accredited continuing education credits/hours

Some participants' needs may require award of accredited continuing education credits/hours and may require additional payment beyond the registration fee for the training. It is the responsibility of individual participants to know what attestation of participation meets their individual needs and to request accredited CE on the day of the program or within one week of the program date. Professionals governed by a health professional regulatory board, office, or agency is responsible for knowing the current law, regulations, rules, and deadlines governing their practice or employment. ILPPP is not able to interpret health professional laws, regulations or rules. Please make check payable to 'ILPPP' .

To claim AMA PRA Category 1 Credits (tm) or Hours of Participation the applicant **MUST** make payment - in the form of a check, payable to 'ILPPP' - in order to receive a unique code that authorizes claiming credit at a secure website. Claiming AMA PRA Category 1 Credits (tm) or Hours of Participation **MUST** be completed ASAP if not on the program date: the platform for claiming the program's credits or Hours expire 30 days after the program.

Award of AMA PRA Category 1 Credits (tm) or Hours of Participation for partial attendance of a program is possible. Participants must claim only the credit commensurate with the extent of their participation in the program.

Virginia Mandatory Continuing Legal Education Board of the Virginia State Bar

For some programs accreditation of CLE credit hours are applied for through the Virginia State Bar's Mandatory Continuing Legal Education Board. Virginia Department of Criminal Justice Services Partial In-Service Credit-Career Development/Elective

For some programs accreditation of Partial In-Service Credit (PIC)-Career Development/Elective hours are applied for through the Virginia Department of Criminal Justice Services (DCJS) for sworn criminal justice officers under the purview of VA DCJS. This program has not been accredited by DCJS.

Fees: There is no fee for award of Partial In-Service Credits.

Of interest to Virginia Social Workers

According to Regulations Governing the Practice of Social Work of the Virginia Board of Social Work at 18 VAC 140-20-10 et seq., Revised December 30, 2015 (Statutory Authority: §§ 54.1-2400 and Chapter 37 of Title 54.1 of the Code of Virginia) regarding continued competency requirements for renewal of an active license contact hours of continuing education may be obtained from a combination of board-approved activities, that may include "workshop, seminars, conferences, or course in the behavioral health field offered by federal, state or local social service agencies, public school systems or licensed health facilities and licensed hospitals" under 18VAC140-20-105. Continued competency requirements for renewal of an active license. The University of Virginia Health System is a licensed hospital.

Of interest to Virginia Counselors

According to Regulations Governing the Practice of Professional Counseling of the Virginia Board of Counseling at 18 VAC 115-20-10 et seq., Revised December 28, 2017 (Statutory Authority: §§ 54.1-2400 and Chapter 35 of Title 54.1 of the Code of Virginia) regarding continued competency requirements for renewal of a license approved hours of continuing competency activity are outlined, and include

- b. Continuing education programs offered by universities or colleges.
- c. Workshops, seminars, conferences, or courses in the behavioral health field offered by federal, state or local governmental agencies or licensed health facilities and licensed hospitals.
- d. Workshops, seminars conferences or courses in the behavioral health field offered by an individual or organization that has been certified or approved by one of the following: naming many organizations, including American Psychological Association.

ILPPP programs are 'continuing education programs offered by a university'. The University of Virginia Health System is a licensed hospital. See ILPPP's accreditation statements regarding American Psychological Association above.
